### Message from the Prez

**Greetings WGLHA members!** 

Some big changes are underway for the Walnut Grove Lake Homeowners Association.

Jeanie Velarde, our devoted bookkeeper since 1994, is resigning. We cannot express how much we appreciate all that she has done for our neighborhood over the past 24 years as bookkeeper and the first four years of that as a Board member. See Cindy Conner Burnett's article about Jeanie in this newsletter.

When we started using our current law firm, Dinkelspiel, Rasmussen & Mink, they were amazed that an HOA as large as ours (471 lots) was self-managed. They said they would have recommended that we hire a management firm right away, except that Jeanie and I seemed to be doing a good job.

With the aging of the neighborhood and covenants compliance becoming an increasingly important issue along with Jeanie's departure, self-management by a volunteer board is no longer a reasonable option.

After interviewing some highly recommended organizations, your board selected Keith S. Collins Co., LLC (KCC), the largest HOA management company in the mid-south. KCC manages 235 HOAs, eight of which are lake communities, mostly located in Cordova, Collierville, Germantown, Rossville, Olive Branch and Southaven. KCC has been in business for over 12 years.

Beginning on October 1, KCC will perform the following services:

- Prepare the operating budget
- Maintaining an operating bank account
- Process dues payments including setting up a system for online payments
- Manage our reserve funds
- Pay invoices
- Provide monthly reports to the Board
- Distribute delinquent notices
- Coordinate the filing of civil warrants and liens

- Prepare any requirements relating to any special assessments
- Conduct periodic physical inspections noting any deficiencies such as deferred maintenance or other issues that need to be addressed
- Solicit and negotiate bids for service contracts
- Provide statements for annual dues
- Respond to homeowner requests and complaints
- Monitor compliance and assist in enforcing all rules in our covenants
- Mail violation letters
- Prepare a directory
- Solicit quotes for the HOA's insurance.

Having a professional management company also will allow your volunteer board to focus on improvements in the community and better serving the needs of all residents.

Homeowners will be receiving a letter from KCC soon with full details in regards to their management. Obtaining these professional services will cost \$42 per lot per year. The HOA will absorb the cost until next fiscal year.

The Board of Directors is confident that this is the best step for our community and is looking forward to working with KCC.

### Beaver Alert!!

We sometimes see evidence of beavers in the lake and they can do some real damage. Living like we do so near a major wetland area, it's virtually impossible to get rid of them permanently. However, there are things that we can do to protect our trees and shrubs. Beavers seem to find sweet gums, crape myrtles, willow, maple, birch, and poplar trees particularly tasty. It often seems that beavers also prefer any other species of tree that is: a) very expensive, b) perfect in your landscape, or c) certain to fall on your house when chewed!



Surround those that are within 20' - 30' of the lake with ¼" hardware cloth or wire mesh and make sure it is *at least* 36" high (48" is even better). Another way to protect your trees is to paint the trunks with grit paint. This is a mixture of about 4 ounces of mason sand per 1 quart of latex paint. You can have the paint matched to the tree bark. Or you can place a short fence (at least 2 feet tall) along your shoreline for protection. A beaver's security is in the water and they normally do not prefer to walk very far around such obstacles if there are food options that are more easily accessed.

Sea walls or rocks along the shoreline are good deterrents to the beavers. They will swim along a sea wall or shoreline until there is an opening where they can easily come onto the land and proceed to chow down. An opening in a sea wall is a perfect place for them to come ashore. If you have an opening that is there for drainage, you can place a piece of chicken wire in front of it to block beavers from entering there. Check your yard and your neighbor's yard along the lake for openings if you have experienced tree damage lately, and patch the holes.

We have a trapper who periodically traps and removes beavers from the lake. Our trapper is **Charles Harris** with Apex Wildlife. He recently caught one beaver. If you notice any recent beaver damage, call Cecil Norwood, our Lake Committee Chair at 412-2290 and he will see what he can do. Please note, however, that some recent beaver damage was done by a beaver or two that traveled around the lake but did not stay, so those are virtually impossible to catch.

### Lake Report

The lake activity has been unusually slow as of late because of the hot temperatures we have had. The fishing has been slow and most successful anglers have had best success early and late. Some good bass were caught in June by a few lucky anglers and good numbers of bream have been caught until the heat stopped the anglers...not the fish! Some tilapia have survived our winter and good sized ones have made their appearance with one even caught at the fishing rodeo. Algae, a common problem at Walnut Grove Lake, seems to not be as bad as in years past. Could this be because of our stocking tilapia? I personally hope so.

We are in the process of retesting our lake water at this time and I will give updated info in our next newsletter.

No recent reports of our arch villain, Justin Beaver, making a nuisance of himself damaging our shrubs, trees, docks etc. Any problems with him or his buddies, call me at 412-2290 and I will contact Apex Wildlife.

Also special thanks to TWRA for the recent geese roundup which was a great success!

As my predecessors have done, I ask that any and all trash be removed from our beautiful lake and that our gutters and drains be kept as clean as possible.

### This 'N That

<u>Volunteers Needed for Website Maintenance & Newsletter</u> – Due to the resignation of Jeanie Velarde, we need someone to keep our website up to date and someone to help with our newsletter. This involves the placement of the articles and posting it on the website.

<u>Solar Lights</u> - Do you have solar lights in your yard? They don't last very long. Check yours to see if they still work and remove them if they don't.

<u>Garbage Carts</u> – Reminder - please make sure your garbage carts are stored out of sight, as required in our covenants.

<u>Garbage</u> - Considering the change in garbage service that we are currently experiencing, the city has asked us to put as much waste as we can in our garbage carts so as to help prevent any potential backlog of outside-of-the-cart service. Please don't leave little piles of sticks at the street – place them in our garbage cart. When you mow, leave the grass clippings on the grass – it adds valuable nutrients to your soil. If you do collect your grass clippings, don't leave the bag at the street until garbage pick-up day. And remember, it may not be picked up for several weeks! You can place that bag in your garbage cart too. Report issues by calling 311, visiting memphistn.gov/government/311/, or using the 311 app on your smartphone.




### Boat Parade Recap

### Jeanie Velarde

Gutsy. It's a word Jeanie Velarde uses to describe the Walnut Grove Lake Homeowners Association Board of Directors. And she should know. Jeanie has been associated with the Board for more than a quarter of a century, for 24 years as bookkeeper, the first four years as a Board member as well. But gutsy is also a good word to describe Jeanie who's currently battling myelodysplasia, a disorder that prevents blood cells from forming normally, with determination and an upbeat attitude.

The rigors of chemotherapy and preparation for a bone marrow transplant have caused the talented quilter and busy grandmother to cut back on some activities. As a result, she recently turned in her resignation to the Board.

"As far as I'm concerned, she's been the rock of the Homeowners Association," said current Board president Margie McMillan. "She's made my job infinitely easier. I couldn't have done it without her." Former Board treasurer Jane Raymond added, "I was always impressed by her dedication to the neighborhood. She respended to requests for information quickly and handled those few grapky neighborhood.



sponded to requests for information quickly and handled those few cranky neighbors with grace."

A resident of WGL since 1986 when she and her husband, Armando, moved to Memphis from Houston, Texas as newlyweds, Jeanie was attracted to the neighborhood from the first time she saw it.

"We loved the lake, the hills and trees and curvy streets, but assumed these were million dollar homes and we couldn't afford them," she recalled. Fortunately her realtor knew better and showed the couple a home on a quiet cove with a secluded backyard that met their needs. "We loved the neighborhood then and we love it now," she said.

The couple was busy settling in and didn't get involved in the neighborhood immediately. "We read the newsletter and went to the civic association meetings but that was about all," Jeanie said. But in 1994 when volunteers were needed to help compile the neighborhood directory, things changed. "I raised my hand and forgot how to say no," she said.

At the time, what is now the Board was a civic organization and the developers still were responsible for management of the subdivision.

During Jeanie's association with the Board, the group took over management of the neighborhood from the developers, renewed a lapsed corporate charter, dealt with embezzlement by a Board member, fought construction of a proposed mall development, worked with Lloyd Lovitt to dredge the lake, battled Hope when they requested a zoning variance to build a structure the Board thought would be detrimental to the neighborhood, rebuilt the spill-way, and rewrote the neighborhood covenants. They also oversaw the addition of a new section of homes to the association and numerous improvements in the appearance of the area as well as new activities such as the fall Dam Party and Easter Egg Hunt.

As the association has grown, so have Jeanie's duties. "I not only send out and pay bills, I help put up signs, work on the newsletter and website, write letters, handle the association phone line, work with the president on covenant violations, work with our attorney to prepare liens for non-payment of dues and whatever else is needed."

Because of her years as a resident she also serves as the resident historian and uses her skills as a seam-stress to make elaborate ribbons for the winners in the various neighborhood contests such as the boat parade, holiday lighting contest and mailbox decorating competition. In addition, she and her husband oversee a neighborhood Little Library they built in their front yard.

"The more you volunteer, the more you get to know your neighbors and feel a part of your neighborhood," Jeanie said. "It just makes your experience here so much better. I've loved doing it and being a part of making this neighborhood a great place to live."

### Fishing Report

Deep summer is the absolute slowest time of the year for fishing. It is often called the "Dog Days" for some unknown reason. Nevertheless, if you go out early (crack of dawn early) I am sure you can have a good chance of catching a few bass. I caught a two-pound bass under Margie's pier the other morning. A seven pound plus bass was caught proving that there are some big bass in the lake.

On another note, the copper-nosed bluegills that were stocked have grown substantially. I caught one on a bass lure and it was almost a pound. In talking to a gentleman who was fly fishing I was told that he has caught many of them and they were all quite large. In addition, I have noticed quite a few minnows around my pier that had the wide shape of a bluegill. A female copper-nosed bluegill lays about 80,000 eggs per year. If they survive they should be a sustainable resource for both the bass and the fishing population.
