Information, please!

Lake passes were mailed to those whose dues are up-to-date. When you use the lake or public areas, please have your pass with you!

Our **courtesy patrol** is checking the neighborhood at scheduled times. The patrol regularly screens for passes. Residents are discouraged from checking the legitimacy of visitors to our public areas.

In June, the board engaged **Aquatic Control Laboratory** to conduct a water quality assessment and harmful algae screen on the water in Walnut Grove Lake. The June 26 report showed that, while the lake water is normal in many respects, there is harmful "**blue-green algae**" in the lake.

Until further notice, do not swim in the lake and keep pets out of the water. Do not consume fish caught in the lake. As always, do not consume the water. If you accidentally enter the water, you should rinse off as soon as possible. If your dog enters the water, you should rinse your dog off as soon as possible. Do not let your dog lick its fur after coming in contact with the lake water.


The board placed signs along the lake to warn people to stay out of the water. While the signs remain up, this advice will remain in effect. Boating is still safe, as is enjoying the scenery from the bank and catch-andrelease fishing, as long as you rinse off after handling fish.

Where did the three months go since the Spring report?

A lot has happened though, that's for sure! Big fish caught, algae growing, and goose population exploding!

With summer comes unauthorized visitors to the lake, including several confrontations with security, requiring intervention by MPD. Be sure to have stickers on your autos, carry your cards, and the yellow badge provided by the HOA. Have WGL lot numbers on all boats. The courtesy has a list of residents.

Water temps range from the high 80s to low 90s with oxygen saturation on the low side. This prevented treating the lake for blue green algae. If we had treated, there was a chance of a fish kill, so the plan was terminated.

Tennessee Wildlife Resources completed a goose round-up and geese were relocated.

Fishing has improved with several 4 to 5 lb. bass being caught and released. Good catches of large bream and a Left few nice crappie have been observed as well. I foul hooked a very large Rig catfish on 6 lb. mono, estimated at 20 + lbs, and got

a good look at it before the hook popped out!

As always, continue your efforts to keep all debris clear of drains. Stay safe and stay well enjoying the rest of your summer!
